



2011 EMERGENCY RELIEF FUND

In response to the devastating damage created in the past three weeks by Hurricane Irene, Tropical Storm Lee and the subsequent flooding, the 2011 Emergency Relief Fund has been created. The intent is to provide emergency relief to our member clubs in need. NYSW has set aside \$20,000 to be used for cash or equipment grants to our affiliates. Individual grants of no more than \$2,000 along with special pricing from key suppliers will help the New York State West community regain its footing.

Eligibility: All affiliates of New York State West that are in good standing in the Binghamton District

To apply, please complete the attached application form. All organizational information must match that which is on file according to your organizations most recent registration information in Rosterpro. The president or chief executive of your organization (as it is Rosterpro) must sign the application, in addition to the person completing the form.

In addition to the application form please submit supporting documentation of your situation including, but not limited to: photos, inventory lists, items in need of repair/replacement and a prioritization of your needs along with requested funding or equipment for each priority of need.

A committee comprised of members of our Board's Executive Committee will determine the recipients and amounts of each grant. [Al and Sherry's Sport Shop in Vestal](#) has committed to working with grantees to get the best price on replacement goods. Where funds need to go towards other issues such as restoration/ rebuilding of your fields or parks, cash awards will be the consideration. The maximum amount of any individual grant will be \$2,000 cash or retail value.

The total number and amount of grants will be based on monies in the fund at the time of application and upon the number of applicants. Monies received from this grant must be used solely for the direct cost of restoring, replacing, or repairing soccer equipment or facilities, which were damaged or lost as a result of the recent flooding. Funding is not to be used for administrative or overhead costs. New York State West reserves the right to inspect the damaged equipment or facility prior to granting the award and/or as follow up.

APPLICATION DEADLINE:

Applications must be received by November 1, but will be accepted immediately. The committee will consider each application upon receipt in an effort to expedite the repair or replacement of any equipment.
