## Role of Clubs

1. Create a safe environment for all of your stakeholders.

2. In good faith, do your best to comply with this new law.

### 1<sup>st</sup> Tenant – AED Machine

Make available an automated external defibrillator or describe reasonable access to an automated external defibrillator at every camp, game and practice.

### 2<sup>nd</sup> Tenant - Training

New York State West

<u>Use best efforts</u> to ensure that there is at least one employee, volunteer, coach, umpire or other qualified adult who is present at each such camp, game and practice who has successfully completed a training course within the preceding <u>twenty-four</u> <u>months</u> of each such camp session, game and practice.

## SECTION 3000-B Automated external defibrillators: Public access providers

A Public Access Defibrillation (PAD) program is designed to encourage greater acquisition, deployment and use of automatic external defibrillators (AED) in communities around the state in an effort to reduce the numbers of deaths associated with sudden cardiac arrest.

## PAD Program Steps

1. Identify a New York State licensed physician or New York State based hospital knowledgeable and experienced in emergency cardiac care to serve as Emergency Health Care Provider (EHCP) to participate in a collaborative agreement (**Recommendation: Contact a local fire department. There is a doctor attached to every local fire department**)

Select an AED that is in compliance with the Article 30, section 3000-B (1)(A). The AED must be programmed to the current Emergency Cardiovascular Care (ECC) Guidelines, capable of defibrillating both adult and pediatric patients. Please check the shaded box on the Notice of Intent to Provide PAD (DOH-4135) if the machine is approved for pediatric use.

## PAD Program Steps

3. Select and use a SEMAC/DOH approved PAD training course for AED users. At present, the 12 approved programs are as follows: (All local fire departments will offer training)

## PAD Program Steps

4. Develop with the EHCP (emergency health care provider), a written collaborative agreement which shall include, but not be limited to the following items:

- Written practice protocols for the use of the AED; (EAP)
- Written policies and procedures which include; (EAP)
- Training requirements for AED users; (AED Plan)

- A process for the immediate notification of EMS by calling of 911; (AED Plan)
- A process for identification of the location of the AED units; (AED Plan)

- A process for routine inspection of the AED unit(s) as well as regular maintenance and which meet or exceed manufacturers recommendations; (AED Plan)
- Incident documentation requirements, and (AED Plan)
- Participation in a regionally approved quality improvement program.

5. Provide written notice to the 911 and/or the community equivalent ambulance dispatch entity of the availability of AED service at the organization's location; See sample letter in PAD program info. sheet.

6. <u>File the Notice of Intent (NOI)</u> to Provide PAD (DOH 4135) and a <u>Signed Collaborative Agreement</u> with the appropriate <u>Regional Emergency Medical Services Council (REMSCO)</u>.

## Definitions

ASSOCIATION

#### **Training Course:**

means a course approved by a nationally-recognized organization or the state emergency medical services council in the operation of automated external defibrillators.

New York State West

#### **Nationally-Recognized Organization:**

A national organization approved by the department for the purpose of training people in use of an automated external defibrillator.

#### Camp:

means a children's overnight camp, summer day camp, or traveling summer day camp, as such terms are defined in section thirteen hundred ninety-two of this chapter, that is subject to regulation by the department.

### Youth Sports Program:

means any league or recreation program organized to provide group athletic activity to individuals under seventeen years old or programs providing athletic activity for high school students regardless of the age of the participants of such programs. Public school athletic programs subject to the requirements of section nine hundred seventeen of the education law shall not be subject to the requirements of this section. 17 <u>Terms</u>

### Legal Issues

Companies and organizations are concerned about their liability for getting and using AEDs. All 50 states and the District of Columbia now include using an AED as part of their Good Samaritan laws. The Cardiac Arrest Survival Act of 2000 encourages placement of AEDs in federal buildings and ensures federal liability protection for those who acquire or use an AED to help save a life. In addition, this act provides limited immunity to persons using the AED and the purchaser of the AED device.

These acts vary by state, but generally, they limit the liability of rescuers using AEDs and others involved in the AED program. Please read the Good Samaritan Act for your state for more specific information. Be sure to have your legal counsel and, if appropriate, your risk management or safety team review your program.
